This letter is to advise principals of grant-aided primary schools that applications for financial assistance to meet the Class Sizes requirement must be submitted to your relevant Education and Library Board (in the case of controlled schools) and via the Council for Catholic Maintained Schools to your Education and Library Board (in the case of maintained schools) **not later than 16 March 2012.**

The funding arrangements which operated for the 2011/12 school year continue to apply. **You are reminded that in order to be considered for additional funding a school MUST first meet the basic criterion that it expects to have a PTR in the 2012/13 school year which is above the NI average of 20.2.** It is not expected that compliance will cause difficulties for the great majority of schools so financial assistance will be required only in a small number of exceptional cases. Principals are also reminded that they must consider how they can implement the policy on an annual basis within their existing or future teaching resources and the formula funded LMS budget. It may also be necessary and appropriate in some instances to redeploy existing teaching resources from Key Stage 2 to Foundation and Key Stage 1 years i.e. P1-P4.

Principals should ensure that they are making the best use of existing resources before seeking additional funding.

Only those applications received on or before 16 March 2012 will be considered for financial assistance.
