De réir fhorálacha Alt 69 (1) agus (6) den Ordú Oideachais agus Leabharlann (Tuaisceart Éireann) 1986, chinn an Roinn Oideachais go mbeidh an liúntas thíosluaite san áireamh sna tuarastail a íocfar le múinteoirí i scoileanna deontaschúnta:

Íocfar suim de £44 le múinteoir a bhfuil ceanglas air/uirthi bheith cláraithe leis an Chomhairle Ghinearálta Teagaisc do Thuaisceart Éireann, maidir leis an táille chlárúcháin a bheidh iníoctha sa bhliain 1 Aibreán 2010 go dtí 31 Márta 2011.

## **DETERMINATION**

In accordance with the provisions of Article 69 (1) and (6) of the Education and Libraries (Northern Ireland) Order 1986, the Department of Education has determined that the salaries to be paid to teachers in grant-aided schools shall include:

### **GENERAL TEACHING COUNCIL FOR NORTHERN IRELAND FEE ALLOWANCE 2010/11**

The sum of £44 will be paid to a teacher who is required to be registered with the General Teaching Council for Northern Ireland, in respect of the registration fee payable in the year 1 April 2010 to 31 March 2011.
