**THE PROCEDURE FOR TRANSFER
FROM PRIMARY TO POST PRIMARY
EDUCATION 2009/2010 –
PROFESSIONAL ASSISTANCE**

1. Under the Procedure for Transfer from Primary to Post Primary Education it will be necessary for Principals of primary schools and preparatory departments of grammar schools to complete Transfer Forms in respect of each pupil transferring and to prepare for, and hold, discussions with parents.

**Controlled and Maintained Primary
Schools and Controlled Grammar
Schools with Preparatory Departments**

2. As you know, in previous years the Department has approved the employment of temporary teaching staff to facilitate this work where school authorities considered that additional assistance was necessary. Substitute teacher costs in respect of Transfer Procedure duties in controlled and maintained schools are an excepted item of expenditure which is held centrally by the Education and Library Boards and are limited to a maximum of Point M4 of the teachers' pay scale. This applies to all grant-aided schools under the Common Funding Scheme for the Local Management of Schools.

4. Mar atá a fhios agat, faoi na socruithe cistithe do bhunscoileanna imeascha agus scoileanna gramadaí deonacha, is mír caiteachais eisceithe iad costais na múinteoirí ionaid i dtaca leis na dualgais a bhaineann leis an Mhodh Aistrithe agus coinníonn an Roinn go lárnach iad agus tá aisíocaíocht teoranta d'uasmhéid Phointe M4 de scala pá na múinteoirí (móide aoisliúntas na bhfhostóirí agus ranníocaíochtaí Árachais Náisiúnta). Mar sin, féadfaidh údarais na scoileanna glacadh leis go bhfuil cead acu múinteoirí sealadacha a fhóstu ar an scála ag paragraf 3 thuas chun an obair sin a éascú, má shíleann siad go bhfuil cúnamh breise de dhíth.

5. I gcás na Ranna Ullmhúcháin i Scoileanna Gramadaí Deonacha, i dtaca le múinteoirí atá fostaithe chun críche an Mhodha Aistrithe, beidh 30% de chostas na dtuarastal, teoranta d'uasmhéid Phointe M4 de scala pá na múinteoirí agus ranníocaíochtaí gaolmhara na bhfhostóirí, inghlactha mar mhír caiteachais eisceithe.

3. The approved limits for the level of assistance for the 2009/2010 Transfer Procedure are as follows:-

Grant-Maintained Integrated Primary Schools and Voluntary Grammar Schools with Preparatory Departments


4. As you know, under the funding arrangements for grant-maintained integrated primary schools and voluntary grammar schools, substitute teacher costs in respect of Transfer Procedure duties are an excepted item of expenditure held centrally by the Department and reimbursement is limited to a maximum of Point M4 of the teachers' pay scale (plus employers' superannuation and National Insurance contributions). School authorities may, therefore, assume approval to the employment of temporary teaching staff on the scale at paragraph 3 above to facilitate this work where they consider that additional assistance is necessary.

5. In the case of Preparatory Departments in Voluntary Grammar Schools, in respect of teachers who are employed for the purpose of the Transfer Procedure, 30% of the cost of salaries, limited to a maximum of Point M4 of the teachers' pay scale and the associated employers' contributions, will be admissible for grant as an expected item of expenditure.

6. 
